III. Review of FY07 Operating Budget Request and FY07 Capital Budget Request and FY07-12 Capital Budget Plan

POLICY CITATION

Regents' Policy 05.01.01.A. - Budget Policy, states, "The budget of the University of Alaska represents an annual operating plan stated in fiscal terms."

RATIONALE

President Hamilton, Vice President Beedle, Associate Vice President Pitney, and Associate Vice President Schointuch will address questions from the Board of Regents and provide additional background and insight regarding the FY07 operating and capital budget request and the 6-year capital plan.

The reference documents attached include an updated Draft FY07 Operating Budget Request Summary, the Draft FY07 Capital Budget Request Summary and the FY07-12 Capital Budget Plan Summary. The operating budget draft has been updated to incorporate committee input from the September 2005 meeting on Agenda

faculty and staff salary support from tuition and fees revenue. The capital request and 6-year plan summary pages are as presented in the September 2005 meeting. The links below provide the complete operating and capital budget packets as presented in September. With the exception of the operating budget update noted, no additional changes have been incorporated.

Although the budget summaries have not changed significantly, much progress is being made on the budget detail. Program priorities have been identified and are being reviewed at the campuses for inclusion in the following operating budget request.

- 1. Continuing program to address state needs
- 2. Preparing Alaskans for new jobs
- 3. Competitive university research investment, and
- 4. Administrative priorities.

The campus performance-based budgeting targets and goals will be received by Friday, October 7, 2005. Refinements on utility cost increases and staff benefit projections continue. On the capital plan and budget request, the complete deferred maintenance list has been submitted to the state for consideration in a comprehensive R&R funding mechanism. The UA deferred maintenance list totals \$444M of which \$94M is included in the FY07 safety, code, ADA and R&R capital budget request priorities. Between this committee meeting and final Board of Regents' approval, scheduled for November 1, 2005, changes and improvements will accommodate the following:

- ø Incorporating Finance Committee input
- ø Incorporating campus performance targets
- ø Finalizing program request for the enhancement/growth categories
- Ø Developing and refining request amounts and narrative descriptions
- Ø Developing consistent presentation format for operating and capital budget requests
- ø Refining capital project descriptions and narratives
- Refining FY08-12 capital planning levels for safety, code and R&R categories to include projects on the full deferred maintenance list
